# ~ Introduction ~

# In the 'Action' NO: 32797/11 of the Scottsdale Magistrates Court on 17th Jan 2012

I Terence Michael Malaher state that since Magistrate Marron 'found' in favour <u>of</u> the State prosecutor that:

I BELIEVE that it is <u>my duty to God</u> and my fellow man/woman to awaken the conscience of the magistrate and mankind so that they do not continue to ERR or stray further INTO the darkness due either to their own ignorance <u>or</u> a failure on my part to do my utmost to enlighten their consciousness and, - - -

I am utilising this open letter to the presiding Magistrate Marron and every 'reader,' a part of which is the telepathic response received from God the Source, and recorded by myself the mortal man Terence, the Spirit of Truth, God's Plenipotentiary, to assist all readers.

Since Magistrate Marron has 'found' in favour of the prosecution I am now at the 'mercy' of the Tasmania Fines enforcement unit who may well decide to extort money which they 'claim' is their FINES due accrued over many years of State persecution of a man of God, a man of peace.

If they do go ahead then both God and all mankind will see the extent of coercion and religious persecution existing in Australia.

Judge Malaher's personal secretary was present at the final 'judgement' imposed and listened to the events as they took place, events that are also available to the public as an audio voice transcript record of the court proceedings.

From this submission and summing up and 'judgement' of Magistrate Marron it is obvious that I <u>do</u> have the necessary 'grounds' for a Supreme Court Appeal, but I have decided not to take that course of action but instead, using this document, I appeal to the <u>conscience</u> of the <u>man</u> Reg. Marron and I now submit the following attestation to him and the general public for their own consideration and 'judgement.'

## $\sim$ Letter to the Magistrate $\sim$

Dear magistrate Reg. Marron, I have sat in your court on a number of occasions and observed that you are a very compassionate and honourable man who does his level best to 'lessen' the punitive blow that is imposed upon offenders that stand before you.

I ask: "How so was it that you were unable to grant <u>me</u> the same courtesy"? For as you read out your 'finding' that led to my "Guilty" conviction I could see the 'struggle' within your conscience, and it appeared to me that you were under duress as you did so.

Thoughts entered my mind at that moment saying to me: "It is regrettable that <u>man</u> by others are forced to twist and weave as they manipulate 'words' to their own advantage so as to justify something but, - - - they see not that it is their <u>own</u> soul that was deceived and ahead does grieve as the result."

You "Yes" do have the RIGHT to sully your own inner 'rose' as you 'dispose' of me so callously but, I also have the RIGHT as agreed by you to seek higher authority, and I <u>thus</u> 'caution' you to never again deny your inner Light and, - - - I give within this document my reasoning and reasons for the <u>ERROR OF JUDGEMENT</u> of <u>your</u> conduct that will form the basis of my 'appeal.'

I have decided to <u>not</u> appeal to any higher court of man but instead I appeal to your conscience as well as to the readers, so that each of you can decide on your future conduct when interacting with other CHILDREN OF GOD.

Both God and I await to see if you are 'man' enough to retract your finding before your 'teeth' are eternally 'grinding' in realms of utter terror in the wastelands below where <u>all</u> the weak minded go.

Try and see that I am not your 'serf' nor am I a slave citizen to be treated with contempt simply because my system of belief and conduct differs somewhat to that which you are paid a wage to enforce.

As I am a man of PEACE I do not 'oppose' you or your judgement in any negative way for as far as I am concerned, any judgement placed upon me by those as you who believe in their RIGHT to defy God and fight or punish or destroy the life or livelihood of others, is IRRELEVANT.

Why? Because due to the belief <u>I</u> hold, I would never retaliate against you for holding the opposing belief, and I would simply <u>offer</u> my 'courteous' response in the HOPE that ahead it saves YOU from eternal <u>GRIEF</u>.

You may or may not believe in the power of our invisible God but I do. I also <u>know</u> that any person or 'gang' member of any 'institution' that <u>coerces</u> using <u>punishment</u> or, <u>forces</u> <u>others</u> to 'bow' to <u>their</u> belief backed by <u>armed men</u> (police or army) are very foolish indeed.

I believe you to be an intelligent and caring man who has been unable to exercise his <u>own</u> 'conscience' reference the 'finding' and subsequent 'punishment' placed upon me.

I therefore 'suggest' that to save your own soul from 'purgatory' that you resign your commission with the State judicial 'authority' and help me uplift the consciousness of all humanity.

It is the time for the <u>whole</u> 'world' <u>and</u> the Judiciary to be better informed <u>before</u> all HELL breaks loose on earth.

# ~ Democracy & your judgement ~

The basic 'founding' of DEMOCRACY is the human Right to live according to ones religious ideology, belief and conscience, and mine is that of **Peace**, and I cannot condone nor can I 'grease' the palms of controllers and extortionists – so –

Magistrate Marron, you believe in the Right to IMPOSE 'grief' upon me for failing to conform with the 'belief' of <u>your</u> organisational 'gang,' being the belief that I <u>must</u> by annual taxes fund their extortionist demands or be <u>punished</u>. Your actions are a defiance of the **Sovereign Authority**. Ref.

# Constitution Act 1934 (Tas)

This document includes a <u>legal guarantee of the religious liberty and equality of Tasmanians</u>. Every citizen is <u>guaranteed freedom of conscience and the free exercise of religion</u> under Section 46(1) of this Act. And in defiance of:

# Commonwealth of Australia Constitution Act (9th July 1900) section 116

"The Commonwealth shall not make any law for establishing any religion, or for <u>imposing any</u> religious observance, or for <u>prohibiting the free exercise of any religion</u>, -

Thus the 'finding' judgement and punitive imposition placed by you upon me is <u>in conflict</u> with and <u>in contravention of</u> the above and <u>is</u> Treason because it ignores the Right of the individual granted to me by the **Sovereign Authority**.

In your summing up you stated that; "The Sect 8 (1) vehicle & traffic act 1999 in no way affects, limits, or obstructs <u>the right</u> to free profession and practise of religion - I find that the provisions of the Commonwealth Constitution <u>have no bearing</u> on the present matter, and I find that all elements of the offence have been established." (As per Court CD record)

Magistrate Marron, by virtue of the FACT that you took it upon yourself to examine the Australian Constitution Act <u>indicates</u> that you would have exonerated me if you <u>had</u> understood the TRUE meaning and implication of the words 'religion & religious observance' because, < the provisions of the Commonwealth & Tasmania Constitutions > <u>do have a bearing</u> on the present matter >

Why? Because I am being punished for <u>not</u> funding by <u>tax</u> your<u>religious belief</u> in your Right to control, tax and punish people. My RELIGIOUS belief precludes <u>me</u> from controlling, taxing or interfering in the lives of, or punishing other people.

I believe that <u>as you are</u> a man of compassion and no 'idiot' <u>I do believe</u> that some other 'body' <u>advised</u> you <u>and</u> coerced <u>you</u> to override your own understanding of said texts and to mete out punishment upon me so as to NOT <u>set</u> any <u>precedent</u> in law.

Why do I say this? Because you obviously CHOSE to ignore the true <u>meaning</u> of the words 'religion & religious observance' - - and because you <u>did</u> impose an opposing religious ideological <u>belief</u> upon me in your 'attempt' to deny <u>me</u> the freedom to NOT fund your contra ideological belief of interference, control, punishment and war <u>without</u> being persecuted by your forces and punished.

Magistrate Marron, your 'finding' is based on a LIE. My 'finding' is based on the TRUTH being, that any person funding your institution by tax or fine <u>is</u> self-proven to be <u>in contravention of</u> God's "*Peace, love, mercy, compassion and forgive*" Command and is a person who <u>is</u> fellow-shipping with the FALSE religion of WAR.

### ~ Judicial Heresy ~

Magistrate Marron, when you order that a man pay a <u>fine</u> as punishment for <u>not</u> subscribing to your ideological belief due to <u>his</u> religious faith being different, it simply means that you <u>are</u> attempting to <u>COERCE</u> him into changing his religious ideology, and this <u>is</u> judicial heresy, treason, and the ULTIMATE treachery, and at that moment you ARE the **Devil's** advocate.

You need to understand that the punishment imposed by you and those before you are <u>all</u> acts of 'coercion' attempting to force me to change my religious <u>allegiance</u> and, this also is an act of TREASON within the texts of your <u>own</u> 'Law' books.

I can categorically state that any person who tries to convert my belief in **Peace** to one in which I support, condone, or fund inquisition, punishment or **War** will excommunicate <u>themselves</u> from Heaven. So sayeth our God.

I am entirely 'fed up' with people who label themselves with the <u>name</u> 'magistrate' when they cannot follow their <u>own</u> 'rules' legislated by the Sovereign 'body' nor their conscience, but who by 'proxy' mete out 'conclusions' for others in positions of power who have a 'grudge' and impose their 'findings' upon the 'innocent' who ARE conforming to the 'rules' of engagement <u>and</u> the Command of their God. Madness abounds everywhere.

Who <u>are</u> these people like Marron, Wilson, Hill and others who <u>believe</u> that they are the 'pillar' of society as they <u>criminally</u> interfere in the lives of other children of God, being those as me who <u>do</u> walk their road each day peacefully?

Can they <u>not</u> see that it is 'insanity' to <u>use</u> a rule in a book to deny another overriding rule in a book as a 'reason' to interfere, control or punish? Where <u>are</u> their 'reasoning' powers? Can they not see that they <u>are</u> criminals for exceeding the mandate granted unto <u>them</u> by the State of Tasmania Constitution <u>and</u> the Commonwealth of Australian Constitution?

Woe and more woe upon their own souls do they place for soon now, not far ahead, very great dark forces will against them wield a powerful mace in JUSTICE for being such a disgrace.

## $\sim$ The ONE Surety granted unto man $\sim$

Magistrate Marron, in a single sentence you ABOLISH the one SURETY granted unto man by the **Sovereign Lord** - being their RIGHT to FREEDOM of Religious belief by your words:

"The Sect 8 (1) vehicle & traffic act 1999 in no way affects, limits, or obstructs the right to free profession and practice of religion - I find that the provisions of the Commonwealth Constitution have no bearing on the present matter, and I find that all elements of the offense have been established."

I ADD that by your words above you <u>condemn</u> your <u>own</u> self as being a selfish terrorist of criminal intent AND deed committing an ACT of TREASON against man AND the Sovereign Lord.

Why? Because the payment of an annual TAX to your institution to maintain a 'validation' of ones driving ability <u>does</u> AFFECT, LIMIT and OBSTRUCT the <u>right of belief</u> to NOT fund the <u>opposing belief</u> in control, interference, punishment or killing of others.

IF I was an 'Agent' of the DARK I would be the one to sever your 'head' with a Sword for the act of Treason, but instead, as I am the Prince of Peace I give you God's HOLY WORD so that you <u>can</u> TRY and regain YOUR freedom from your present 'bondage' to the **Dark Sovereign Power**.

Magistrate Marron you need to ask yourself:

"Does the invisible God have the power and 'how or why' to punish me for my infidelity"?

**Note:** Magistrate Marron is proven to be a **despotic dictator**. How and why? Because he is <u>dictating</u> the <u>terms and conditions</u> of Religious ideological beliefs that <u>he</u> says <u>must</u> be conformed with by me and, as I failed to conform with his interpretation I am to be disadvantaged and <u>punished</u>.

The 'magisterial' Dictate from this <u>finding</u> means that I cannot live in peace according to my belief because, unless I live <u>according to the belief</u> of Magistrate Marron I will have to suffer the consequences.

It is to be seen within this 'judgement' that Magistrate Marron clearly believes that <u>his</u> belief supersedes mine. In summary Magistrate Marron failed to see that his 'finding' was based upon the <u>imposition</u> of <u>his</u> belief and this is of itself <u>in contravention of</u> the Australian Constitutional LAW.

Common law <u>must</u> conform with Constitutional legislation and, Constitutional legislation does <u>not</u> supersede the "*Go your way in peace & love one another*" Command of God. If it so does then it <u>is</u> THE LAW OF THE BEAST.

### $\sim$ The Law of the BEAST $\sim$

"Do what thou wilt using my force" is the LAW of the BEAST, and any person that commands or reprimands others <u>in an attempt</u> to <u>force</u> them to <u>change</u> their ideological belief is using 'beastly force' <u>in contravention of</u> the code of conduct policy of the reigning Constitutional Sovereign power and authority granted to lesser mortals.

Not only are these 'infidels' who seek to thwart the Freedom of Religion clause living in a state of delusion, but they <u>are</u> also exceeding their mandate, and are taking a <u>false</u> wage as they <u>mislead</u> the members of the police force who do try and do their duty honourably.

Magistrate Marron, your 'finding' ruling places the police and prison service into the very dishonourable role of themselves having to defy the Sovereign Authority because <u>you</u> have so 'judged' and said.

It follows that any 'fines enforcement' or police interference in my life or incarceration of my 'body' is an ACT of Treason on their part because it is 'done' <u>without</u> conformity to the RULE OF LAW of your <u>own</u> 'text' books and it is <u>also</u> defiance of God.

By your 'pen' you <u>are</u> invoking the 'Law of the Beast' that <u>leads you to believe</u> that you may "Do what thou wilt as there is NO consequence to you."

Magistrate Marron, I do know that our invisible to you God <u>does</u> exist, and you need to ask yourself: "Why am I in the 'magistrate' business when all my daily duties are in conflict with my benign conscience"

I can but add that you need to <u>become</u> a spiritual counsellor who gives assistance as they educate the needy. Please become a LIGHT WORKER.

Men of NO conscience \* take a '30 pieces of silver' wage to <u>be</u> a 'mercenary' and defy God as they control the lives of others 'judiciously' or otherwise.

**Note:** No conscience – means that one cannot exercise ones conscience when ones rulings <u>are</u> dictated by <u>text</u> in a book, for text is but text and has NO conscience.

You Mr. Marron are 'too good a man' to be a magistrate using his 'powers' to coerce or punish. You need to now join my 'way' and only 'judge' as do I, meaning, that I judge whether or not a person is erring and in need of EDUCATIVE correction rather than fining them and impoverishing their family and <u>causing</u> other punitive HARM.

### $\sim$ The 'kangaroo court $\sim$

**It is** quite plain to me the soul from eternity that the mind and 'pen' of magistrate Marron was overruled by instruction or 'influence' from a higher authority, and he thus totally disregarded his 'duty of care' Mandate and, - - -

He exceeded IT in his pre-sentence summary in a deliberate manner as he did 'over-roll' his <u>own</u> judicious nature through his 'fear' that <u>he</u> would be seen as 'weak' if he permitted me to walk free..

By this 'act' of utter irresponsibility he damned his <u>own</u> soul as being unworthy of his 'silk' and <u>became</u> a sad 'figure' nailing himself to the **CROSS of Satan** as being no less than a <u>SWINE</u> unworthy of his wage as <u>he</u> condemned <u>me</u> God's sage sent to earth to elevate <u>his</u> soul.

Magistrate Marron chose to ignore the "Responsibility of Magistrates." (Extract from: <u>http://www.peo.gov.au/faq/faq\_23.html</u>) 23.1 Reference the role the courts play in Australian governance. The role of the Judiciary is to:

- apply the law as made by the Parliament
- where necessary, interpret the laws made by Parliament
- ensure that laws comply with the <u>Australian Constitution</u>

Magistrate Marron was/is totally unaware that his erroneous 'judgement' would continue to <u>mislead</u> the police, since his ruling has given them the 'licence' <u>to continue on</u> in the 'persecution' of a *peaceful* community member who for one reason or another does not conform with the beliefs of officials of the State, the Courts, the Magistrate and others.

Magistrate Marron failed to see that his own BELIEF was/is error, being: That <u>he believes that</u> I <u>do not have the right to believe</u> in my absolute right under the legal judgement of the Constitution that clearly stipulates that I <u>can</u> live according to <u>God's</u> Command, <u>my</u> conscience and <u>my</u> religious ideology of PEACE in <u>not</u> funding contra warring, intrusive, controlling and punitive institutions.

He also failed to see that the Constitution strictly <u>prohibits</u> that a person be <u>punished</u> for failing to 'bow' to the 'contra' beliefs of State Institutions or of other mortal men.

The belief system of the State <u>rules</u> is predicated upon a 'belief' that ones 'freedom to live' unhindered is contingent upon payment of an annual TAX. The demand of an annual 'license fee tax' is simply a 'political' edict.

The issue at stake is whether or not a person who believes in absolute PEACE <u>at all times</u> and <u>in all situations</u> is required, by law, to make such a 'Tax' contribution to state coffers or not.

Taking into account my ideological belief that I must <u>not</u> fund any person or 'institution' that is <u>proven</u> to have a conflicting ideological belief, it is clear that I <u>have</u> (should have) the protection of the Sovereign Power within the 'Freedom of Religion' Act of the Constitution, and any person denying that is in grave error of judgement.

In this instance Magistrate Marron failed to see that his 'judgement' in favour of State official 'demands,' with the accompanying consequential punishment imposed, is a <u>coercive</u> attempt to <u>force</u> me to <u>change my religious ideological belief</u> by <u>forcing</u> me to fund an institution <u>that has the</u> <u>proven CONTRA belief</u> to the one I hold.

Magistrate Marron is in direct contravention of, and in violation by infringement, of his <u>own</u> Law, since it is CLEAR that the payment of Tax to an opposing ideological belief system IS an 'infringement' upon my belief.

The Magistrate is of the belief that <u>he</u> can override and simply ignore the Constitutional Law <u>as</u> <u>well as</u> the ideological belief of others. This shows that the Magistrate is absolutely 'unconscionable' and treasonable to the point that - - -

<u>Due to his personal belief</u> - - - he is prepared to disregard the Law of the land that he is paid to uphold, - - - <u>as well as</u> disregarding the BELIEF'S and the RIGHT'S of the <u>peaceful</u> and, literally 'throw' <u>them</u> to the waiting wolves to be cast out and 'devoured.'

It is quite clear to me that Magistrate Marron exceeded the mandate granted unto him by the Constitutional Authority of the State and Commonwealth Constitutions. In so doing it follows that <u>he</u> is guilty of Treason against the **Sovereign Power**.

<u>Let it be clearly understood</u> that by his judgement, Magistrate Marron is setting yet another 'precedent' whereby his ruling opposes the 'Freedom of Religion' Act/clause.

Magistrate Marron has not only <u>erred</u> in Law, but he has avoided <u>using</u> the Law without seeing the <u>terrible consequences</u> unto <u>others</u> and EQUALLY unto <u>himself</u> within <u>God's</u> LAW.

By his erroneous verdict the magistrate <u>enforces</u> the belief of State officials in <u>their</u> RIGHT to <u>override</u> the beliefs of <u>others</u> and to use <u>force</u> to control, subjugate, tax, punish, disadvantage, banish and evict and thereby destroy the life and livelihood of any of their 'victims.'

Magistrate Marron, through this action, failed to see that it was/is <u>in absolute contravention of</u> God's Command and <u>in absolute contravention of</u> and in conflict with the 'Freedom of religion' Clauses of the Constitution of Tasmania and the Commonwealth. In this instance <u>he</u> showed <u>contempt for the Law of the Land</u> as determined by the Constitution <u>and</u> God.

As Magistrate Marron states and acknowledges with CERTAINTY that I <u>have</u> the right of religious freedom being the fundamental RIGHT of every person on the land, it is the Magistrate who has the LEGAL OBLIGATION to set me <u>free</u> within the Acts of the Tasmania & Australia Constitutional LAW that clearly override State rules. It follows that the 'verdict' is UNLAWFULLY imposed.

Further let it be known that his ruling <u>also</u> <u>misdirects</u> the plaintiff since it gives the police and others the <u>false belief</u> in their presumed legal 'right' to <u>seize</u> property which does not belong to 'them.'

Magistrate Marron did himself and others an INJUSTICE by <u>failing to understand</u> the true nature <u>and</u> implications of the case prior to 'judging' it.

Magistrate Marron failed to see that in 'allowing' the case 'for' the Plaintiff that it would <u>facilitate</u> the ongoing persecution and imposition of mental and emotional trauma, physical stress and loss and deprivation of/to the defendant.

Since from the above it is obvious that this hearing was a farce to cover the pre-determined outcome, it is important for <u>all</u> to understand both the legal and spiritual implication of what occurred in this matter.

Magistrate Marron failed to absorb the <u>legal implications</u> contained within the defence. The failure to do so results in the Magistrate placing his <u>own</u> soul within the <u>punitive</u> aspect of God's One Law: "*As you sow so shall ye reap*."

Magistrate Marron also fails to see that he is in fact inciting civil unrest amongst members of the community due to his own conscious 'conscience' <u>decision</u> to disobey his supreme commander.

Woe unto all mortals who from now on enter the 'portals' of the Australian kangaroo courts, for there is NO 'Justice' to be found because, by 'mad men' you <u>will</u> be bound unless as me you can see their error and you refuse to pay their coercive extortionist attempts.

Why do I say this? Because if you <u>do</u> pay <u>any</u> 'fine' then you <u>are</u> unknowingly funding the pockets of ignorant 'swine' and keeping <u>them</u> in power and in 'ignorance' of <u>their error</u> of way and you also <u>become</u> complicit to their control over other poor children of God who as all are trapped within the web of iniquity.

My soul is FREE so they the ignorant cannot 'taint' IT I say, for irrespective of what they do to my body, - - - my soul is uncontaminated and IT will rise UP eventually.

I am no 'fool,' thus I do <u>not</u> sit before Satan's 'footstool' and bow to His wishes projected through vain, arrogant, or ignorant mortals of any 'station.'

I simply do my best to awaken them <u>before</u> they crawl into the 'warren' far below seeking to hide from the unspeakable terrors that lurk EVERYWHERE.

# $\sim$ Superior intelligence $\sim$

Whether you are living on this 'earth' or on any other level of consciousness outside the pure Light of Heaven you are living in a realm that <u>is</u> controlled by the **Dark Sovereign Power**, God the Father.

What is this invisible power? It is the power of Superior intelligence that keeps man 'locked' into the false belief (delusion) that control, regulation, punishment and killing is justified.

Thus simple man believes falsely that it is legal and thus 'legitimate' to use force of arms (power) to accomplish control and revenge etc., and <u>not</u> suffer any consequence if he is using 'legislation' as his authority. That belief <u>is</u> the gravest error of the day. Why?

Because it is thus that man keeps himself 'locked' into the punitive aspect of God's ONE immutable Law: "As you do unto others will be done unto you" and, - - -

The contradiction being whereby other mortals backed by force of arms do interfere in our lives with seeming impunity and do extort endless sums of money from our income and do punish us for non-conformity to their 'ways,' being their 'Text in books' demands, decrees, rules, edicts that they name 'The Law.'

Where is God in all this and why does HE 'permit' such ongoing INIQUITY and suffering to be imposed upon all? Can our God in fact elevate us out of this 'misery' and can He destroy us for any reason? The answer is "Yes" and I clarify my reasons below.

I can but say that God has THE power to accomplish anything and this He does using the power of His MIND and I simply write this 'text' document in the hope that you the individual do not continue to be a 'dope' and end up hanging on the end of a rope dead, either physically or spiritually.

As ones 'religion' is in fact ones code of conduct POLICY interaction with others, be it benign and loving or malignant and punitive, and as we do have the RIGHT to live in accordance with our belief being our 'religion,' we simply need to understand a few things:

For they see not that their legislated **rules** and positions of **power** in NO WAY 'de-power' God or the imposition of His 'Justice' factor and, - - -

NO 'badge of office' protects any state official from the imposition of God's Law upon them when they exceed the precepts of His "Peace, love, mercy, compassion and forgive" Command in their interaction with you or me. Wide indeed is the road to Hell.

The ONLY WAY 'clear' for anyone is to never fund, condone or support the control or interference in or, coercive tax extortion of OTHERS. Only support the provision of benign community effort or service provision.

Those who defy God and disturb the peace of the land must be caught, counselled and educated and NOT punished, for ONLY thus do we remain in conformity to the precepts of God's Command and thus avoid His PAINFUL REPRIMAND.

Any of you that fail to make Peace with God by changing your ways so that you do extend 'Peace and goodwill unto all,' will fail and fall.

Ignorantia Juris neminem excusat - Ignorance of the Law excuses no one.

<u>It needs to be clearly understood</u> by the 'reader' of this judgement that <u>living the practice of</u> <u>ones belief</u> is ones RELIGION. The proof of ones religion is our daily <u>interaction with others</u> for all to see, be it peaceful, benign, merciful & forgiving – or - intrusive, malignant, unforgiving & punitive.

Every magistrate and every 'reader' of this document needs to UNDERSTAND that people of 'like mind' to myself do NOT have to 'live' by the rules of legislators employed in institutions of man, - - -

For we 'bow' to our <u>God</u> as we CONFORM with/to His Command as we adhere to ITS precepts in all we do each day, as we walk, talk, and interact with His other children of every race or creed.

We never 'consider' punishing them or making them bleed for <u>our</u> 'policy' <u>is</u> one of Peace & love & mercy and forgiveness and, - - -

If ever <u>we</u> are abused or confined or restricted in any way we simply 'turn the other cheek' and remain kindly and <u>meek</u> unto our ignorant <u>persecutors</u> IN THE KNOWLEDGE that they have been sent against us by our God in order to 'balance' His Scales of Justice for some <u>past</u> error on our part when we in some way turned our hand against others.

Thus all or any 'views' or decisions or ranting or punitive impositions mean NAUGHT, for due to our belief our freedom to RETURN to the Light has been 'paid for' through our own desire to remain peaceful in the face of adversity, and to NEVER raise our voice or hand against any other child of God and, to <u>never</u> pay the wages of 'servants' to do such to others on our behalf or in our name
